ANNEX 1  
FORM TRADEMARK ASSIGNMENT AGREEMENT

THIS ASSIGNMENT OF TRADEMARKS (this "Assignment") is made as of November 29, 2013 ("Effective Date") by Actavis Puerto Rico Holdings Inc., a Delaware corporation ("Assignor"), in favor of Warner Chilcott Company, LLC, a limited liability company organized under the laws of the Commonwealth of Puerto Rico ("Assignee").

WHEREAS, Assignor owns and either uses or has the bona fide intent to use the trademarks and service marks set forth on Schedule A hereto, which are registered, or for which applications for registration have been filed and are pending, in the United States Patent and Trademark Office and/or the Canadian Intellectual Property Office (the "Marks");

WHEREAS, Assignor and Assignee have entered into that certain Contribution Agreement, dated as of November 29, 2013 (as it may be amended, supplemented or otherwise modified from time to time, the "Contribution Agreement"); and

WHEREAS, pursuant to the Contribution Agreement, Assignor has agreed to transfer, convey, assign and deliver all of Assignor's right, title and interest in and to the Marks to Assignee, and Assignee has agreed to accept and assume the Marks from Assignor.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor agrees as follows:

Assignor hereby transfers, conveys, assigns and delivers to Assignee all of Assignor's right, title and interest in, to and under the Marks, together with (i) all goodwill of the business connected with the use thereof and symbolized thereby, and (ii) all registrations and applications for registration in connection therewith, and all extensions and renewals thereof, and (iii) any past, present or future claims or causes of action arising out of or related to any infringement, dilution or other violation of any of the foregoing, and the right to sue or otherwise recover therefor, the same to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

This Assignment shall be governed by and construed in accordance with the laws of the State of New York, United States of America, without giving effect to the principles of conflicts of laws thereof.

IN WITNESS WHEREOF, Assignor has caused this Assignment to be executed by its duly authorized representative as of the Effective Date.


