
WHEREAS, pursuant to agreement, Assignor did wish to assign to Assignee the MARK; and

AND, Assignor agrees, at the request of Assignee, to execute any further papers necessary to effect transfer of the IP as may be required for recordation in a form substantially as set forth herein of this Assignment; and to secure for the Assignee in its full and complete enjoyment of its right to the IP at Assignee's expense.
