## Trademark Assignment

**THIS TRADEMARK ASSIGNMENT** is made as of March 1, 2015 (the "Effective Date") between Amada Home Care, Inc. and Faatafa F. Jefferson as well as Chad B. Fotheringham.

**WHEREAS**, Amada Home Care, Inc., a California corporation, with a principal address of 24361 El Toro Rd., Suite 205, Laguna Woods, California 92637 ("Assignor"), is the owner of the trademark set forth in the accompanying Schedule A (the "Mark");

**WHEREAS**, Faatafa F. Jefferson, a United States citizen having an address of 37 Scarlett Maple Drive, Ladera Ranch, California 92694 and Chad B. Fotheringham, also a United States citizen with an address of 28 Via Divertise, San Clemente, California 92673 (the "Assignees"), are desirous of acquiring said Mark and all title, rights and interest worldwide in, to and under the common law as well as to any registered trademarks together with the goodwill of the business with which the Mark is used and which it symbolizes;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, delivers conveys, assigns and transfers to Assignees, free and clear of all security interests, liens, equities, claims, or options of every kind, all right, title and interest in and to the Mark, including any applications to register the Mark, together with the goodwill of the business symbolized by the Mark, all common law rights related to the Mark, all rights of renewal and extension, and the right to recover for damages and profits for past infringements thereof. All rights to sue for infringement thereof, whether arising on, prior to or subsequent to the date of this Assignment, and any and all applications, registrations, renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect worldwide including in the United States, are to be held and enjoyed by Assignees, their successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made. Assignees do hereby accept all of the right, title and interest of the Assignor in the Mark, to and under all of the foregoing.

The parties hereto further agree as follows:


- 1) The Assignor agrees that it shall promptly deliver to the Assignees such deeds, bills of sale, endorsements, consents, assignments and other good and sufficient instruments of conveyance and assignment as the Parties and their respective counsel shall deem reasonably necessary or appropriate to vest in the Assignees all of its right, title and interest in, to and under the Mark.
- 2) The covenants and agreements contained in this Assignment are for the sole benefit of the Parties hereto and their respective successors and permitted assigns and shall not be construed as conferring and are not intended to confer any rights on any other persons.

- 3) All of the terms and provisions of this Assignment shall be binding on, and shall inure to the benefit of, the respective legal successors and permitted assigns of the Parties.
- 4) This Assignment may be executed in counterparts, each of which may be deemed an original but together shall constitute but one and the same instrument. Such counterparts may be executed and delivered by facsimile or other electronic means by any of the Parties, and the receiving Party may rely on the receipt of such document so executed and delivered as if the original had been received.
- 5) Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of California without giving effect to the principles of conflicts of laws thereof.
