**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This Release, effective as of November 18, 2016, is granted by Deutsche Bank Trust Company Americas, a New York banking corporation, with its principal office at 60 Wall Street, New York, NY 10005 to Accuride EMI, LLC, a Delaware corporation (the "Grantor"), with its principal office at 7140 Office Circle, Evansville, IN 47715, as follows:


WHEREAS, the Notes Priority Collateral Agent wishes to release and restore all right, title and interest in and to the Intellectual Property to the Grantor and to dissolve any and all liens and encumbrances respecting the Intellectual Property under the Security Agreement and the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Notes Priority Collateral Agent, without recourse and without representation or warranty of any kind (either express or implied), hereby terminates, releases, retransfers, reassigns, forever discharges, quit claims and relinquishes unto the Grantor the security interest in the Intellectual Property set forth on Schedule A.
