### TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates, cancels and discharges, without recourse and without representation or warranty of any kind (either express or implied), any and all of its interest in the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens.

The Administrative Agent hereby authorizes and requests that the Commissioner of Trademarks note and record the existence of this Termination and Release of Security Interest in Trademarks.
