The Assignor represents and warrants that it has not assigned its rights, title and interests associated to the Mark to any third party. The Assignor shall make all necessary formalities to carry out this Assignment at the Assignee's expense, including those necessary to allow the Assignee to record the change of ownership of the Mark and perfecting title before the relevant governmental authorities.

This Assignment and any dispute or claim arising out of or in connection with shall be governed by and construed in accordance with the laws of the Province of Quebec and those of Canada applicable therein.

Each party irrevocably agrees that the courts of the province of Quebec, Canada, and no other courts, shall have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with this agreement or its subject matter or formation (including non-contractual disputes or claims).
