## TRADEMARK SECURITY AGREEMENT

Trademark Security Agreement (this "Agreement") dated as of 11/25, 2016 by and between PRECISION FABRICS GROUP, INC., a North Carolina corporation (the "Grantor"), and WELLS FARGO BANK, NATIONAL ASSOCIATION (successor-in-interest to Wachovia Bank, National Association), a national banking association (the "Lender"), under the terms of that certain Amended and Restated Security Agreement dated as of September 29, 2016 (as amended, restated, supplemented or otherwise modified, the "Security Agreement") by and between the Grantor and the Lender.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantor hereby grants to the Lender a continuing security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:


- (i) each trademark, trademark registration, and trademark application, and in each case, all of the goodwill of the business connected therewith, and symbolized thereby, including, without limitation, each trademark, trademark registration and trademark application described on Schedule A attached hereto;
- (ii) all claims by the Grantor against third parties for (a) past, present or future infringement or dilution of any trademark, including, without limitation, any trademark described on Schedule A attached hereto or (b) injury to the goodwill associated with any trademark; and
- (iii) all products and proceeds of the foregoing.

The rights and remedies of the Lender with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
