**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Release") is executed as of November 17, 2016, by ACADEMY BANK, N.A. (the "Secured Party") in favor of DATAMENTORS, LLC (the "Released Party").

**WHEREAS**, pursuant to the terms of that certain Amended and Restated Trademark Security Agreement dated as of February 27, 2015, by and between the TELEMATCH, INC. ("Telematch") and the Secured Party (the "Security Agreement") as recorded with the United States Patent and Trademark Office ("USPTO") on May 13, 2015, at Reel 005515, Frame 0286, the Telematch granted to the Secured Party a security interest in and lien on the trademarks identified on Schedule A attached hereto (the "Marks");

**WHEREAS**, pursuant to the terms of that certain Trademark Assignment dated as of July 22, 2015, recorded with the USPTO on July 23, 2015, at Reel 5583, Frame 0525, Telematch assigned to Released Party all of its rights, title and interests in, to and under the Marks and the goodwill associated therewith; and

**WHEREAS**, the Secured Party wishes to release the security interest in and lien on (i) the trademark registrations and applications set forth on Schedule A hereto, together with the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof; (ii) all rights of any kind whatsoever of Telematch or Released Party accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world; (iii) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and (iv) any and all claims and causes of action, with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages (collectively, the "Trademark Collateral");

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party states as follows:

The Secured Party hereby terminates, releases, and discharges its security interest in and lien on the Trademark Collateral, and the Secured Party hereby assigns and transfers to the Released Party without recourse or representation or warranty, express or implied, of any kind, all of its right, title and interest in and to the Trademark Collateral identified on Schedule A attached hereto, effective as of the date set forth above.

The Secured Party understands and agrees that this Release may be recorded by or for the Released Party with the USPTO or any similar office or agency within or outside the United States.
