**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of November 9, 2016 (the “Effective Date”), is made by CITIBANK, N.A., in its capacity as Administrative Agent (the “Agent”), in favor of the grantor parties identified on Schedule A hereto (individually, a “Grantor”, collectively the “Grantors”).

WHEREAS, pursuant to that certain Security Agreement, dated as of August 4, 2010, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Agent, in its capacity as Administrative Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered those certain Trademark Security Agreements, dated as of August 4, 2010; February 11, 2011; June 10, 2011; July 13, 2011; April 30, 2012; December 19, 2012; and December 9, 2014 (collectively, “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on August 19, 2010 at Reel/Frame 4263/0471; February 17, 2011 at Reel/Frame 4481/0947; June 17, 2011 at Reel/Frame 4563/0968; July 13, 2011 at Reel/Frame 4582/0460; May 18, 2012 at Reel/Frame 4784/0267; January 8, 2013 at Reel/Frame 4937/0809; and December 10, 2014 at Reel/Frame 5417/0290;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels in full any and all of its security interest in and to the Trademarks, including the trademark registrations and applications set forth on Schedule B attached hereto and all Proceeds of any and all of the foregoing, arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to such Trademarks under the Trademark Security Agreements or the Security Agreement, the Agent hereby re-transfers, re-conveys and re-assigns any and all such right, title or interest to the Grantor. Any security interest or other right, title or interest of the Agent in such Trademarks shall hereby cease and become void.
3. Termination. The Agent terminates and cancels the Trademark Security Agreements and Security Agreement.
4. Further Assurances. The Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release. The Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer note and record the release hereby given

and any other filings necessary to evidence the release and termination of the Agent's rights under each of the Trademark Security Agreements and Security Agreement, with respect to the Trademarks.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.


