ASSIGNMENT OF SHORT-FORM IP SECURITY AGREEMENT

RETAILER CREDIT SERVICES, INC., a Delaware corporation, successor by merger to GE CAPITAL BANK, a Utah industrial loan corporation ("*Assignor*"), having an address at c/o GE Capital US Holdings, Inc., 901 Main Avenue, Norwalk, CT 06851, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, hereby sells, transfers, assigns, delivers, sets over and conveys unto Element Financial LLC, a Delaware limited liability company (formerly known as Element Financial Corp.) ("*Assignee*"), having an address at 161 Bay Street, Suite 3600, Toronto, ON M5J 2S1, Attention: Jim Nikopoulos, and its successors and permitted assigns, all of the right, title and interest of Assignor in, to and under that certain Short-Form IP Security Agreement, entered into as of June 22, 2012, pursuant to which Me-N-Ed's Pizzerias, Inc., a Nevada corporation, Piazza del Pane, Inc., a California corporation, Sienacorp., a California corporation, Angelo & Vito's Pizzeria, Inc., a California corporation, Milano Marketing International, Inc., a California corporation, Milano International Development Corp., a California corporation, Me-N-Ed's Ceres, Inc., a California corporation, Milano Restaurants International Corp., a Nevada corporation, and Milano International Equipment Corp., a California corporation (collectively, as Grantor) granted to Assignor (as Lender) a security interest in and lien upon all of such Grantor's Intellectual Property (as defined in the underlying Loan Agreement), including, without limitation, the trademarks listed on the attached Exhibit A.

This Assignment of Short Form IP Security Agreement is made without representation, recourse or warranty by Assignor, except as provided in that certain Asset Purchase Agreement (the "*Purchase Agreement*") by and between GE Capital US Holdings, Inc. and Assignee, dated as of June 30, 2016. Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Purchase Agreement.


