PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "Release") is made effective as of November 15, 2016 by Byline Bank, an Illinois banking corporation, d/b/a and as a successor in interest to Ridgestone Bank (in such capacity, the "Lender") in favor of Blue Lake Citrus Products, LLC, a Florida limited liability company ("Grantor").

WHEREAS, reference is made to certain Trademark and Patent Security Agreement dated as of May 20, 2010 (as the same may be amended, modified, extended, supplemented or restated from time to time, the "Security Agreement"), by and among the Grantor, WM. G. Roe & Sons, Inc., K & R Equipment Repair, Inc. and the Lender, which was entered into pursuant to that certain Loan Agreement, dated May 20, 2010, between the aforementioned persons ("Loan Agreement");

WHEREAS, the Recordation Form Cover Sheet was recorded in the United States Patent and Trademark Office on June 21, 2010 at Reel 4229 and Frame 0951 (the "Notice of Security Interest");

WHEREAS, in accordance with the provisions of the Security Agreement, the Lender now desires to release its security interest in to and all Grantor intellectual property referred to in the Security Agreement and the Notice of Security Interest, including without limitation, the trademark registrations and/or applications listed on Schedule A attached hereto (the "Trademarks").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

1. Defined Terms. Each capitalized term used but not defined in this Release has the meaning given or ascribed to it in the Security Agreement.
2. Release of Grant of Security. Lender hereby (i) terminates the Notice of Security Interest with respect to all Grantor intellectual property, and (ii) terminates, releases and discharges its security interest in, and reassigns to Grantor all right, title and interest to, all Grantor intellectual property, including without limitation the intellectual property referred to in the Notice of Security Interest, the Security Agreement and the Loan Agreement, including without limitation, the Trademarks.
3. Recordation. Lender hereby authorizes Grantor or any of its authorized representatives to file this Release with the United States Patent and Trademark Office or any other applicable governmental office. The Lender hereby further authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release
4. Further Assurances. Lender hereby agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by Grantor, at Grantor's expense, to fully effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.

6. Counterparts. This Release may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

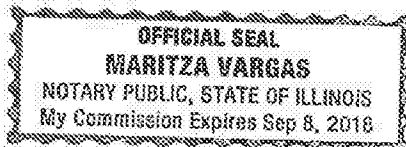

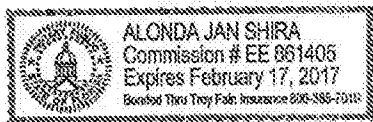
