**RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS**

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS, dated as of November 29, 2016 (this "Release"), is made by Bank of America, N.A. (the "Agent"), in its capacity as collateral agent under that certain Second Lien Credit Agreement, dated as of November 15, 2013, as amended by that certain Amendment No. 1 to Second Lien Credit Agreement, dated as of May 21, 2014, that certain Amendment No. 2 to Second Lien Credit Agreement, dated as of February 12, 2016 and that certain Amendment No. 3 to Second Lien Credit Agreement, dated as of the date hereof (as further amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among Lanyon Solutions, Inc. (f/k/a The Active Network Inc.), a Delaware corporation, and Lanyon, Inc., a Delaware corporation ("Lanyon"), (collectively, the "Pledgors"), Athlaction Holdings, LLC, a Delaware limited liability company ("Holdings"), certain subsidiaries of Holdings from time to time party thereto, the lenders from time to time party thereto and the several agents party thereto, including the Agent. Capitalized terms used but not defined herein shall have the meanings set forth in the Credit Agreement.

**WITNESSETH:**

WHEREAS, the Pledgors are party to a Second Lien Security Agreement of even date with the Credit Agreement (as amended, amended and restated, supplemented, waived or otherwise modified from time to time, the "Second Lien Security Agreement") in favor of the Agent and the Second Lien Trademark Security Agreements, dated as of November 15, 2013, which were recorded with the United States Trademark and Trademark Office ("USPTO") on November 18, 2013 at Reel/Frame Nos. 5155/0884 and 5155/0891 (the "Second Lien Trademark Security Agreements," and collectively with the Second Lien Security Agreement, the "Security Agreements");

WHEREAS pursuant to the Security Agreements, Pledgors granted to the Agent a Lien on and security interest in all of their right, title and interest in, to and under the Trademark Collateral (as defined in the Second Lien Trademark Security Agreement), including with respect to the trademark registrations and applications listed on Schedule 1 attached hereto;

WHEREAS, Pledgors desire that the Agent terminate and release any and all right, title and interest it may have in the Trademark Collateral pursuant to the Credit Agreement and the Security Agreements, and the Agent has agreed to do so; and

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees, for the benefit of Pledgors, as follows:

SECTION 1. *Release of Security Interest in Trademark Collateral.* The Agent does hereby terminate, release, relinquish and discharge its Lien on and security interest in the Trademark Collateral, and hereby assigns and transfers to Pledgors all right, title and interest that the Agent may have, if any, in the Trademark Collateral including all goodwill associated therewith.

SECTION 2. *Further Assurances.* The Agent hereby authorizes Pledgors or their authorized representative(s) (i) to record this Release with the USPTO, (ii) file UCC financing statement amendments or terminations, as applicable, in order to memorialize the release of the security interest of the Agent in the Trademark Collateral and (iii) otherwise record or file this Release in applicable governmental offices or agencies. The Agent further authorizes and requests that the USPTO Commissioner for Trademarks, and any other necessary United States government officer, record this Release. The Agent further agrees to execute and deliver to Pledgors any and all further documents and instruments, and do any and all further acts which Pledgors (or their designees) reasonably request, all at Pledgors' sole cost and expense, in order to confirm this Release and Pledgors' right, title and interest in, to and under the Trademark Collateral.


SECTION 3. *Governing Law.* This Release shall be governed by and construed in accordance with the laws of the State of New York.


