CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, for the avoidance of doubt, Assignor wishes to confirm that the Assigned Assets include the U.S. trademark ONE ENGAGEMENT HUB;

NOW, THEREFORE, in return for good and valuable consideration, the receipt and adequacy of which Assignor acknowledges, Assignor states as follows:


1. Confirmation of Assignment. Assignor hereby confirms its assignment to Assignee of all of Assignor's right, title, and interest in and to: (a) the U.S. trademark ONE ENGAGEMENT HUB ("Trademark"), including without limitation U.S. application Serial No. 86313342 for the Trademark ("Application") and any and all application, registration, maintenance, and renewal rights with respect to the Trademark and all the goodwill of that business that deals in any or all of the goods and services set forth in the Application or with which the Trademark has been used or is used, in association therewith; (b) any and all actions and rights of action for infringement, misappropriation, or other violation, including without limitation the right to sue and collect damages for past infringement, of the foregoing right, title, and interest in and to the Trademark or otherwise with respect to the Trademark, whether arising before, on, or after the execution date hereof; and (c) any and all other rights arising from or associated with the Trademark.

2. Governing Law. This Assignment will be construed in accordance with, and any and all actions arising hereunder will be governed by, the laws of England and Wales without regard to those jurisdictions' choice-of-law rules.
