**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "*Release*"), dated as of December 1, 2016 (the "*Effective Date*"), is made by Highbridge Principal Strategies, LLC, in its capacity as collateral agent for itself and the other Secured Parties (the "*Secured Party*").

WHEREAS, Crane & Co., Inc., a Massachusetts corporation, Crane & Co., Inc., a Massachusetts corporation, William Arthur, Inc., a Maine corporation, and Visual Physics, LLC, a Georgia limited liability company, (collectively the "*Borrowers*") granted the Secured Party a security interest (the "*Security Interest*") in trademarks identified on Schedule A hereto ("*Trademarks*") to the Secured Party under a Grant Of A Security Interest - Trademarks, dated as of September 29, 2014 by and between the Borrowers and the Secured Party (the "*Security Agreement*");

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office at Reel/Frame 5371/0001 on September 30, 2014

WHEREAS, the title, rights and interest in the Trademarks are held by the Borrowers;

WHEREAS, Borrowers request that the Secured Party terminate and release the entirety of its Security Interest in the Trademarks; and

WHEREAS, the Secured Party grants such request.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Secured Party hereto agrees as follows:

1. Release. The Secured Party hereby terminates and releases the Security Interest in the Trademarks and hereby transfers and assigns to Borrowers any and all of its right, title and interest in and to the Trademarks.

2. Recordation. The Secured Party hereby authorizes and requests that the Commissioner of Patent and Trademarks and any other applicable United States government officer record this Release.
