CONSULTING AND LICENSE AGREEMENT

THIS CONSULTING AND LICENSE AGREEMENT (the "Agreement") is made by and between Julia Dyckman Andrus Memorial, Inc., a New York corporation with principal offices located at 1156 North Broadway, Yonkers, New York 10701 (hereinafter "Andrus"), Sandra Bloom, MD, an individual residing at 13 Druim Moir Lane, Philadelphia, PA 19118 ("Dr. Bloom") and Community Works, Inc., a Pennsylvania corporation with its registered address at 13 Druim Moir Lane, Philadelphia, PA 19118 ("Community Works").

RECITALS

- A. The Sanctuary Model was designed by Dr. Bloom to guide an organization in the development of a trauma informed culture in an effort to provide a sound treatment environment for individuals recovering from the damaging effects of interpersonal trauma (the "Sanctuary Model");
- B. Community Works has caused Dr. Bloom to provide consulting services to Andrus as described herein, including training, teaching and program development services related to the Sanctuary Model and Andrus desires such services to continue;
- C. Andrus and Community Works (through Dr. Bloom) currently offer training courses to organizations that wish to use the Sanctuary Model to better serve clients under their care (the "Sanctuary Institute");
- D. The Sanctuary Institute combines on site evaluation, classroom style lectures, written materials and experiential learning to teach program attendees how to implement the Sanctuary Model. Organizations that attend the program and meet certain standards are then eligible to receive a certification (the "Sanctuary Certification").
- E. Dr. Bloom owns the federally registered service marks SANCTUARY and SANCTUARY IN THE SCHOOLS (Reg. Nos. 1,745,328 and 2,845,493);
- F. Dr. Bloom and Andrus jointly developed much of the curriculum and the written materials used by the Sanctuary Institute (as defined herein), and have filed or will file for jointly owned copyright registrations for certain of these materials; and
- G. On May 9, 2008, Andrus filed with the United States Patent & Trademark Office an application to register the mark SANCTUARY INSTITUTE (Ser. No. 77/470096).

NOW, THEREFORE in consideration of the mutual covenants and promises contained herein, and other good and valuable consideration the sufficiency of which is hereby acknowledged, the parties agree as follows:

- (e) Dr. Bloom shall retain all right, title and interest in the SANCTUARY and SANCTUARY IN THE SCHOOLS service marks for the remainder of her life (and thereafter, should this Agreement terminate for cause prior to her death) and United States Trademark Reg. Nos. 1,745,328 and 2,845,493 for the same. With respect to pending United States Trademark Registration Application Ser. No. 77/470096 for the mark SANCTUARY INSTITUTE, Andrus shall assign to Dr. Bloom all rights in the SANCTUARY INSTITUTE service mark pursuant to the Trademark Assignment Agreement attached hereto as Exhibit 1. The SANCTUARY, SANCTUARY INSTITUTE and SANCTUARY IN THE SCHOOLS service marks (and their respective registrations and/or applications) are collectively referred to hereafter as the "SANCTUARY Marks."
- (f) Dr. Bloom shall grant to Andrus an exclusive license to use the SANCTUARY Marks pursuant to the Trademark License Agreement attached hereto as Exhibit 2.
