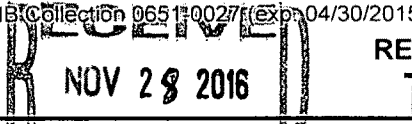

RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **November 16, 2016** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain **Security Agreement**, dated as of **June 14, 1995** and recorded **August 7, 1995** in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **LAMIN-ART, INC.**, (the "Debtor") and the Secured Party;

WITNESSETH:




