**CERTIFICATE OF CONVERSION TO LIMITED LIABILITY COMPANY**

This Certificate of Conversion to Limited Liability Company, dated as of December 26, 2001, is being duly executed and filed by Reman Holdings, Inc., a Delaware corporation (the "Company"), and Marian T. Ryan, as an authorized person of Reman Holdings, L.L.C., a Delaware limited liability company (the "LLC"), to convert the Company to the LLC, under the Delaware Limited Liability Company Act (6 Del. 4. The conversion of the Company to the LLC has been approved in accordance with the provisions of Section 266 of the GCL.

5. The conversion of the Company to the LLC shall be effective at 12:01 AM, E.S.T., on December 31, 2001
