## **FIRST SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT**

This First Supplement to Trademark Security Agreement (this "Supplement") is made as of December 2, 2016 by and between **ACCESS INTELLIGENCE LLC**, a Delaware limited liability company (the "Company") and **THE PRIVATEBANK AND TRUST COMPANY**, as Administrative Agent (the "Agent").

**WHEREAS**, the Company executed and delivered a Trademark Security Agreement dated December 27, 2012 and recorded on January 29, 2013 at Reel 4958, Frame 0783 (as amended of record from time to time hereinafter, the "Agreement") in favor of the Agent, pursuant to which the Company pledged, assigned and granted a security interest in certain Trademarks (as defined therein); and

**WHEREAS**, the Company developed additional Trademarks and desire to hereby confirm the pledge of, and the grant of a security interest in, such additional Trademarks in favor of Agent; and

**NOW, THEREFORE**, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Agreement.

  - a. Except as provided herein, all terms and conditions of the Agreement remain in full force and effect. The Company hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
  - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
  - c. This Supplement shall be construed in accordance with and governed by the laws of the State of New York.
