## TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Troy Newman, an individual whose mailing address is PO Box 782888 Wichita, KS 67278 ("Assignor") has adopted and is using the mark OPERATION RESCUE (the "Mark"). Assignor is the owner of such Mark together with the goodwill of the business in connection with which the Mark have been used (the "Goodwill").

### TERMS AND CONDITIONS

Section 1 - Assignment. In return for good and valuable consideration provided by Assignee to Assignor, the receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee and its successors and assigns Assignor's entire right, title, and interest in and to the Mark and the Goodwill, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its subsidiaries, licensees, successors, assigns, and legal representatives, for the full extent of the life of the Mark, to be used as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment not been made, including without limitation all right, title and interest in and to United States Trademark Registration No. 3179591.

Section 2 - Defense of Rights. Assignor further grants to Assignee the right to sue for past infringement, dilution, and any other violation of rights in the Mark and the Goodwill. The expense of such suits to protect the rights in the Mark and the Goodwill shall be borne entirely by Assignee, and any and all recoveries from any suit or settlement shall go to Assignee.


Section 3 - Warranty. Assignor represents and warrants that it has full power to make this Assignment, and that Assignor has not and will not execute any agreement in conflict herewith.


