**RELEASE OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

This Release of Security Interest in United States Trademarks, dated as of December 5, 2016 (this “Release”) is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as administrative agent (in such capacity, the “Grantee”), in favor of MORAN FOODS, LLC, a Missouri limited liability company (the “Grantor”).

WHEREAS, the Grantor entered into that certain Security Agreement dated as of August 30, 2012 (as amended, restated, supplemented, or modified, the “Security Agreement”);

WHEREAS, pursuant to the terms of the Security Agreement, Grantor delivered to the Grantee a Grant of Security Interest in United States Trademarks dated as of August 30, 2012 (the “Grant of Security Interest”);

WHEREAS, the Grant of Security Interest was recorded with the United States Patent and Trademark Office on October 26, 2012, at Reel 4911, Frame 0938; and

WHEREAS, the Grantor has satisfied all of its obligations under the Security Agreement and has requested that the Grantee terminate and release its security interest in and liens on the below-defined Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Defined Terms. All capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Grant of Security Interest.

2. Release of Security Interest. The Grantee hereby terminates, releases, and discharges its security interest in and liens on the following (collectively, the “Trademark Collateral”):

(a) all of the Grantor’s right, title, and interest in, to, and under to the United States trademarks, tradenames, trade styles, and service marks, and all trademark registrations and use-based trademark applications and recordings (the “Marks”), including, without limitation, those set forth on Schedule A attached hereto;

(b) all rights and privileges arising under applicable law with respect to Grantor’s use of any Marks, and all reissues, extensions, continuation, and renewals thereof;


(c) all prints and labels on which any Marks have appeared or will appear, and all designs and general intangibles of a like nature;

(d) the goodwill of the business symbolized by each of the Marks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Marks; and

(e) all rights corresponding thereto.
