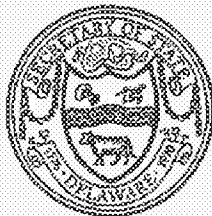

Andera, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Parent" or the "Company"), DOES HEREBY CERTIFY to the following facts relating to the merger (the "Merger") of oFlows Incorporated, a corporation organized and existing under the laws of the State of California (the "Subsidiary"), into the Parent:

FIRST: That it was first incorporated on the 15th day of June, 2000, pursuant to the General Corporation Law of the State of Rhode Island, and subsequently reincorporated on the 22nd day of September, 2010, pursuant to the General Corporation Law of the State of Delaware, the provisions of which permit the merger of a corporation of another state with a corporation organized and existing under the laws of said state.

SECOND: That the Subsidiary was organized on the 2nd day of February, 2009, pursuant to the General Corporation Law of the State of California, the provisions of which permit the merger of a corporation of another state with a corporation organized and existing under the laws of said state.

THIRD: The authorized capital stock of the Parent consists of 803,280 shares of Common Stock, \$0.001 par value, and 378,431 shares of Preferred Stock, \$0.001 par value.

FOURTH: That the Parent owns 100% of the outstanding shares of capital stock of the Subsidiary.

FIFTH: The surviving corporation in the Merger is the Parent. Upon the effectiveness of the filing of this Certificate of Ownership and Merger, the Certificate of Incorporation of the Parent shall remain the Certificate of Incorporation of the surviving corporation in the Merger.

SIXTH: That the Parent's Board of Directors (the "Board"), by the unanimous written consent of its directors, filed with the minutes of the Board, on the 29th day of March, 2014, resolved to merge the Subsidiary with and into the Parent, with the Parent surviving the Merger, and did adopt the following resolutions approving the Merger:

WHEREAS, it has been proposed that the Company effect a merger (the "Merger") of the Company with oFlows Incorporated, a California corporation

NOW, THEREFORE, BE IT RESOLVED, that the Merger be, and hereby is, approved in all respects;

RESOLVED FURTHER, that the Board has determined that the Merger is advisable and in the best interest of the stockholders of the Company;

RESOLVED FURTHER, that the officers of the Company be, and each of them acting singly hereby is, authorized and directed to solicit the written consent of the stockholders of the Company in connection with the approval of the Merger;

RESOLVED FURTHER, that the officers of the Company be, and each of them acting singly hereby is, authorized, for and in the name and on behalf of the Company, to take any and all actions which they may deem necessary or advisable in order to consummate the proposed Merger, including the filing of a Certificate of Merger with the Secretaries of State of Delaware and California and with such other offices or agencies as may be necessary or appropriate;

RESOLVED FURTHER, that the Merger shall be effective in Delaware upon the filing of the Certificate of Ownership and Merger with the Secretary of State of the State of Delaware and in California upon the filing of a certified copy of the Certificate of Ownership and Merger with the Secretary of State of the State of California.


SEVENTH: That the proposed Merger has been adopted, approved, certified, executed and acknowledged by this corporation in accordance with the laws of the State of Delaware, under which it was organized.
