CERTIFICATE OF INCORPORATION

Under Sections 228 and 242 of the General
Corporation Law of the State of Delaware

Grantham Education Corporation, a Delaware corporation (the "Corporation"), does certify as follows:

- 1 The Corporation's board of directors by unanimous written consent dated as of March 3, 2016, adopted resolutions setting forth a proposed amendment to the Corporation's Certificate Of Incorporation, declaring such amendment to be advisable and calling for the submission of such amendment to the Corporation's stockholders for their consideration of it. The resolution setting forth the proposed amendment is as follows:

Now, THEREFORE, BE IT RESOLVED, Article FIRST of the Company's Certificate Of Incorporation is amended to read in its entirety as follows:

"FIRST: The corporation's name is The Level Playing Field Corporation (the "Corporation")."

- 2 Later, under section 228 of the Delaware General Corporation Law, a written consent approving the amendment to the Corporation's Certificate Of Incorporation was signed by the holders of outstanding voting stock having not less than the minimum number of votes that would be necessary to authorize or take such action at a meeting on such date at which all shares entitled to vote thereon were present and voted.
- 3 The amendment to the Corporation's Certificate Of Incorporation was duly adopted in accordance with section 242 of the Delaware General Corporation Law.
