TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 15, 2016 (this "Release"), is made by ANTARES CAPITAL L.P., a Delaware limited partnership (the "Successor Agent") for the benefit of Agent and Lenders (as defined in the Trademark Security Agreement referred to below) in favor of Masergy Communications, Inc., a Delaware corporation ("Masergy") and Masergy Cloud UC Corporation ("Masergy Cloud") (Masergy and Masergy Cloud collectively herein called (the "Grantor").

WHEREAS, pursuant to the Credit Agreement dated as of September 19, 2014 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") among the Borrower, Holdings, General Electric Capital Corporation, (the "Retiring Agent"), and the Lenders and the L/C Issuers from time to time party thereto, the Lenders and the L/C Issuers provided for extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Guaranty and Security Agreement dated as of September 19, 2014 (the "Security Agreement") and the Trademark Security Agreement dated as of September 19, 2014 (the "Trademark Security Agreement"), Grantor granted to Retiring Agent for the benefit of the Secured Parties a security interest in the Trademark Collateral, including Trademarks listed on Schedule A;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on September 19, 2014 in Reel 005366 Frame 0006;

WHEREAS, pursuant to that certain Omnibus Agency Transfer Agreement and Assignment of Trademark Security Agreement by and among the Retiring Agent, and the Successor Agent, Retiring Agent has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Trademark Security Agreement (as the same may have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time), in each instance, in its capacity as administrative agent and, if applicable, collateral agent; and

WHEREAS, the Assignment of Patent Security Agreement was recorded at the USPTO on August 25, 2015 in Reel 5608 Frame 0323; and a corrective filing was recorded on October 14, 2015 at Reel 5644, Frame 0893.

NOW THEREFOR, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the Successor Agent (for itself and as agent for the Lenders and the L/C Issuers) and Grantor (the "parties") agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Trademark Security Agreement.

SECTION 2. Termination and Release. The Successor Agent, for itself and as agent for the Lenders and the L/C Issuers, hereby:

(a) terminates the Trademark Security Agreement, Security Agreement, and any other agreement under which Grantor has granted a collateral mortgage, pledge, hypothecation, grant, assignment, Lien, or security interest in, to, and under the Trademark Collateral;

(b) cancels, discharges, and releases the mortgage, pledge, and hypothecation and Lien on and security interest in, all of its right, title, and interest in, to, and under the Trademark Collateral, including the Trademark Collateral listed on Schedule A attached hereto; and

(c) authorizes the recordation of this Release with the USPTO.



