RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS

This Release of Security Interest in Intellectual Property Rights (this "Intellectual Property Release") is dated as of December 7, 2016 and made by **ITOCHU International Inc.**, a corporation organized and existing under the laws of the State of New York ("Collateral Agent") in favor of **Chrome Hearts LLC**, a Delaware limited liability company ("Debtor").

WHEREAS, Pursuant to a Collateral Agency, Intercreditor and Security Agreement and a Trademark Security Agreement entered into as of March 1, 2005 (collectively, the "Itochu Agreements") Debtor and other debtors granted Collateral Agent a security interest in Debtor's Trademark Collateral, defined as: (i) Debtor's present and future United States registered trademarks and trademark registrations, including Debtor's United States registered trademarks and trademark registrations listed in the annexed *Exhibit A* to this Intellectual Property Release and all of Debtor's present and future United State applications for trademark registrations listed on the annexed *Exhibit A* to this Intellectual Property Release and all of Debtor's present and future trademarks that are not registered in the United States Patent and Trademark Office (collectively, the "Marks"), including without limitation, any and all royalties, payments and other amounts payable to Debtor in connection with the Marks, together with all renewals and extensions of the Marks, the right to recover for all past, present, and future infringements of the Marks, and all other rights of every kind whatsoever accruing thereunder or pertaining thereto; (ii) all of Debtor's right, title and interest in and to any and all present and future license agreements with respect to the Trademark Collateral; (iii) all present and future accounts and other rights to payment arising from, in connection with or relating to the Trademark Collateral; (iv) all goodwill of the business connected with the use of, and symbolized by, each of the Marks; (v) all products and proceeds of any and all of the foregoing (collectively, the Itochu Security Interest"); and,

WHEREAS, Collateral Agent arranged for the recordation of the Itochu Security Interest in the United States Patent and Trademark Office ("USPTO") twice, once on June 1, 2005 at Reel: 3164 / Frame: 0459 and a second time on July 27, 2005 at Reel: 3165 / Frame 0583; and,

WHEREAS, Debtor has satisfied the Obligations defined in the Itochu Agreements; and,

WHEREAS, the Collateral Agent and Debtor have not previously executed and filed any Intellectual Property Releases in the USPTO after full payment was made of the Obligations contained in the Itochu Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiently of which is hereby acknowledged, Collateral Agent, on behalf of itself and for all other parties for whom Collateral Agent was acting as an agent for the Trademark Collateral, as well as its successors and/or assigns does hereby terminate and forever discharge and release, on its behalf Itochu Security Interest in and to the Trademark Collateral including, without limitation, the specific intellectual property identified on *Exhibit A*, annexed hereto.

The validity, interpretation and enforcement of this Intellectual Property Release whether in contract, tort, equity or otherwise, shall be governed by the internal laws of the State of New York but excluding any principles of conflict of laws or other rule of law that would cause the application of the law of any jurisdiction other than the laws of the State of New York.

IN WITNESS WHEREOF, Collateral Agent has executed and delivered this Intellectual Property Release or caused this Intellectual Property Release to be duly executed and delivered by its officer thereunto duly authorized as of the date written below.
