**RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF  
COLLATERAL**

WHEREAS, Strike, LLC, a Texas limited liability company ("**Debtor**"), with its principal place of business at 1800 Hughes Landing Blvd., Suite 500, The Woodlands, Texas 77380, granted a security interest in and lien upon all trademarks, trade names, trade styles and service marks and related rights (the "**Trademarks**") to Compass Bank, in its capacity as Administrative Agent ("**Agent**") as set forth in (i) that certain Trademark Security Agreement Supplement, dated as of August 30, 2013, between Debtor and Agent (the "**Trademark Security Agreement**");

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby:

1. releases, terminates, discharges and reassigns to Debtor any and all liens, security interests, right, title and interest of Agent pursuant to the Trademark Security Agreement, including but not limited to, the Trademarks described in **Schedule A** annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, and the Collateral, and hereby terminates the Trademark Security Agreement, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtor to Agent pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.


