## Release Of Security Interest In Trademarks

This Release of Security Interest in Trademarks (this "Release") is made as of December 19, 2016, by Madison Capital Funding LLC, in its capacity as Agent for Lenders ("Madison Capital"), in favor of Cintas Holdings LLC ("Cintas Holdings"), as successor by merger of Metro Door, Inc. ("Metro Door") and by assignment from Cintas Corporation No. 2 ("Cintas Corporation").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated December 1, 2004, between Metro Door and Madison Capital (the "Security Agreement"), Metro Door granted to Madison Capital a security interest in and to Metro Door's right, title and interest in, to and under certain of Metro Door's trademarks, including those set forth on Exhibit A attached hereto ("Trademarks");

WHEREAS, Cintas Holdings, as noted above, is the respective successor to Metro Door as a result of the merger of Metro Door into Cintas Corporation No. 2 on December 10, 2010 and subsequent assignment of rights from Cintas Corporation No. 2 on May 16, 2011 with respect to Metro Door's rights in the Trademarks, and as such is authorized to enter into this Release;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on December 7, 2004 at Reel 2985, Frame 0780; and

WHEREAS, Cintas Holdings and Madison Capital have agreed that the security interest in and to the Trademarks shall be terminated.



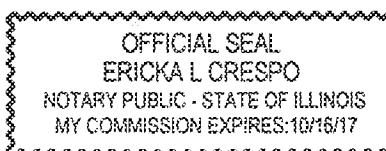
