INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("IP Assignment"), dated as of November 28, 2016, is made by **DELOITTE RESTRUCTURING INC.**, in its capacity as Trustee of the Estate of **Blue Mountain Wallcoverings Group Inc.**, and not in its personal capacity (hereinafter collectively "Vendor/Seller"), in favor of **KITTRICH CORPORATION**, a California corporation with offices at 1585 West Mission Boulevard, Pomona, California 91766 (hereinafter as "Purchaser"), the purchaser of certain assets of Vendor/Seller pursuant to a Purchase and Sale Agreement between Purchaser and Vendor/Seller, dated as of November 28, 2016, (the "**Purchase and Sale Agreement**").

WHEREAS, under the terms of the Purchase and Sale Agreement, Vendor/Seller has conveyed, transferred, and assigned to Purchaser, among other assets, certain intellectual property of Vendor/Seller, and has agreed to execute and deliver this IP Assignment, for recording with all competent governmental authorities and entities in any country, including, but not limited to the United States Patent and Trademark Office, the United States Copyright Office;

NOW THEREFORE, the parties agree, as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Vendor/Seller hereby irrevocably conveys, transfers, and assigns to Purchaser, and Purchaser hereby accepts, all of Vendor/Seller's right, title, and interest in and to the following (the "**Assigned IP**"):

(a) the trademark registrations and applications set forth on Schedule 1 hereto and all issuances, extensions, and renewals thereof and any common law trademarks (the "**Trademarks**"), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks; provided that, with respect to the United States intent-to-use trademark applications set forth on Schedule 1 hereto, the transfer of such applications accompanies, pursuant to the Purchase and Sale Agreement, the transfer of Vendor/Seller's business, or portion of the business to which the trademark pertains, and that business is ongoing and existing;

(b) the copyright registrations and applications for registration and exclusive copyright licenses set forth on Schedule 2 hereto and all issuances, extensions, and renewals thereof (the "**Copyrights**");

(c) all rights of any kind whatsoever of Vendor/Seller accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(d) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(e) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default,

with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Vendor/Seller hereby authorizes all competent authorities and entities and the officials thereof in any applicable jurisdictions to record and register this IP Assignment upon request by Purchaser. Following the date hereof, upon Purchaser's reasonable request, Vendor/Seller shall take such steps and actions, and provide such cooperation and assistance to Purchaser and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned IP to Purchaser, or any assignee or successor thereto. If the Purchaser is unable to obtain (e.g. because of Vendor/Seller's mental or physical incapacity, dissolution or for any other reason,) Vendor/Seller's cooperation, assistance or signature to effectuate the transfers of the Assigned IP known or discovered in the future, then Vendor/Seller hereby irrevocably designates and appoints the Purchaser, its duly authorized officers and agents thereof as Vendor/Seller's agent and attorney in fact, to act for and in Vendor/Seller's behalf and stead to execute or pursue any Assigned IP known or discovered in the future and to do all other lawfully permitted acts to further the transfer of ownership of the Assigned IP to the Purchaser with the same legal force and effect as if executed or pursued by Vendor/Seller.

3. Terms of the Purchase and Sale Agreement. The parties hereto acknowledge and agree that this IP Assignment is entered into pursuant to the Purchase and Sale Agreement, to which reference is made for a further statement of the rights and obligations of Vendor/Seller and Purchaser with respect to the Assigned IP. The representations, warranties, covenants, agreements, and indemnities contained in the Purchase and Sale Agreement, if any, shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase and Sale Agreement and the terms hereof, the terms of the Purchase and Sale Agreement shall govern.

4. Counterparts. This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.


5. Successors and Assigns. This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.





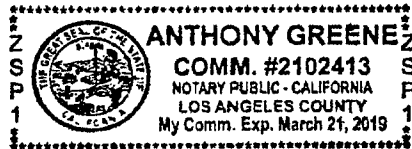
