WHEREAS, PROJECT SPORT, LLC, a Delaware limited liability company (the “Grantor”), granted a security interest to U.S. BANK NATIONAL ASSOCIATION, a national banking association (the “Grantee”), as administrative agent, in the United States trademarks listed in Exhibit A attached hereto and in the other collateral (collectively, the “Collateral”) pursuant to that certain Pledge and Security Agreement and Irrevocable Proxy dated as of August 15, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, the Grantee desires to release the marks listed in Exhibit A from the Confirmatory Grant.

NOW THEREFORE, to all who it may concern be it known that for and in consideration of the payment to the Grantee with respect to the indebtedness described in the Security Agreement, the Grantee hereby (a) releases and discharges all the security interests granted by the Confirmatory Grant, being the security interests granted in respect of the trademarks and all other Collateral, and (b) acknowledges, confirms and agrees that the Confirmatory Grant is discharged, released and terminated and of no further force or effect.


