TRADEMARK ASSIGNMENT

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

Be it known that in consideration of the payment by Assignee to Assignor of the sum of ten dollars (\$10.00) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, and transfers unto Assignee its entire worldwide right, title and interest in and to the Trademark and Trademarks, and the business and business goodwill associated therewith, including, without limitation, all proceeds therefrom (including, but not limited to, all license royalties and proceeds of infringement suits), the right to sue for past, present, and future infringements, and the goodwill of the business associated with and symbolized by the Trademark and trade dress. It is understood and acknowledged that pursuant to a separate Asset Purchase Agreement, Assignee is the successor to the portion of Assignor's business to which the Trademark pertains and that business is ongoing and existing for purposes of 15 U.S.C. § 1060.
