WITNESSETH:

WHEREAS, TIMI has adopted, used, and is using in its business the trademarks set forth in SCHEDULE A attached hereto and made part of this assignment, which are registered or applied for in the United States Patent and Trademark Office and in selected foreign trademark offices;

WHEREAS, FORJAS TAURUS is desirous of acquiring said trademarks set forth in the attached **SCHEDULE A** and the respective registrations and applications for registration thereof, together with the goodwill of the business in connection therewith.


NOW THEREFORE, for valuable consideration furnished by FORJAS TAURUS to TIMI, receipt and sufficiency of which TIMI hereby acknowledges, TIMI hereby, without reservation:

- 1) assigns, sells, and transfers to FORJAS TAURUS, its successors and assigns, the entire right, title and interest in and to the said trademark registrations and applications for registration set forth in **SCHEDULE A**, together with the goodwill of the business symbolized by said trademarks and registrations, and including all claims for damages by reason of infringement of said trademarks and registrations with the right to sue for damages and collect the same from and prior to the Effective Date, all for FORJAS TAURUS' use and for the use of its successors and assigns;

- 2) authorizes and requests the Commissioner of the United States Patents and Trademark Office and the empowered officials of all other governments to issue or transfer all said trademark registrations and applications for registration listed in **SCHEDULE A** to FORJAS TAURUS, as assignee of the entire right, title and interest therein, or otherwise as FORJAS TAURUS may direct;
- 3) warrants that TIMI has not knowingly conveyed to others any right in said trademarks, or any license to use the same; and that TIMI has good right to assign the same to FORJAS TAURUS without encumbrance; and
- 4) Binds TIMI's heirs, legal representatives, and assigns, as well as TIMI itself, to do, upon FORJAS TAURUS' request and at FORJAS TAURUS' expense, but without additional consideration to TIMI or FORJAS TAURUS, all acts reasonably serving to assure that said trademarks and registrations shall be held and enjoyed by FORJAS TAURUS as fully and entirely as the same could have been held and enjoyed by TIMI, TIMI's heirs, legal representatives, and assigns if this Assignment had not been made; and particularly to execute and deliver to FORJAS TAURUS all lawful application documents, and any assignments, disclaimers, and lawful affidavits in form and substance as may be requested by FORJAS TAURUS; to communicate to FORJAS TAURUS all facts known to TIMI relating to said trademarks and registrations, or the history thereof; and to furnish FORJAS TAURUS with any and all documents, photographs, samples and other physical exhibits in TIMI's control or in the control of TIMI's heirs, legal representatives, or assigns, which may be useful for establishing the facts of TIMI's first use of said trademarks and registrations, and first use in commerce.

IN WITNESS WHEREOF, TIMI has caused this ASSIGNMENT to be executed.




