LaSalle Street, Chicago, Illinois 60603, pursuant to that certain (i) that certain Security Agreement dated as of December 19, 2003, by and among the grantors from time to time party thereto and the Administrative Agent for the Secured Parties referenced therein (as the same may have been amended, modified, restated, or supplemented from time to time, the "2003 Security Agreement"), (ii) that certain Guaranty and Collateral Agreement dated as of May 5, 2008, by and among the grantors from time to time party thereto and the Administrative Agent for the Secured Parties referenced therein (as the same may have been amended, modified, restated, or supplemented from time to time, the "2008 Security Agreement") and (iii) that certain Amended and Restated Security and Pledge Agreement dated as of March 17, 2016, by and among the grantors from time to time party thereto and the Administrative Agent for the Secured Parties referenced therein (as the same may have been amended, modified, restated, or supplemented from time to time, the "2016 Security Agreement" and with the 2003 Security Agreement and 2008 Security Agreement, each a "Security Agreement" and collectively, the "Security Agreements"), does hereby unconditionally and expressly release, terminate and forever discharge and extinguish any and all of its right, title and interest in and to any and all liens and security interests it may have under all intellectual property collateral identified in the Security Agreement and (A) the Trademark Security Agreement dated as of December 19, 2003 between the Administrative Agent and The Segerdahl Corp. ("Grantor") (the "2003 Trademark Security Agreement"), (B) the Patent and Trademark Security dated as of May 5, 2008, between the Administrative Agent and the Grantor (the "2008 Trademark Security Agreement") and (C) the Notice of Grant of Security Interest in Trademarks dated as of March 17, 2016, between the Administrative Agent and the Grantor (the "2016 Trademark Security Agreement" and with the 2003 Trademark Security Agreement and 2008 Trademark Security Agreement, each a "Trademark Security Agreement" and collectively, the "Trademark Security Agreements"), including, without limitation, the trademarks listed on Schedule 1 attached hereto (collectively, the "Released Collateral"), arising from the Security Agreements and the Trademark Security Agreements, which was recorded in the United States Patent and Trademark Office ("PTO") on or about (x) June 21, 2004 with respect to the 2003 Trademark Security Agreement, (y) June 9, 2008 with respect to the 2008 Security Agreement, and (z) March 17, 2016 with respect to the 2016 Trademark Security Agreement, against the United States trademarks listed on Schedule 1 at (1) Reel/Frame Numbers 2876/0440 with respect to the 2003 Trademark Security Agreement, (2) Reel/Frame Numbers 3792/0323 with respect to the 2008 Trademark Security Agreement and (3) Reel/Frame Numbers 5753/0109 with respect to the 2016 Trademark Security Agreement. The Administrative Agent hereby (i) releases, retransfers and reassigns to Grantor the security interest and all of the Administrative Agent's right, title and interest in, to and under the Released Collateral and (ii) terminates the Trademark Security Agreements. The Administrative Agent will take all such further actions, execute and deliver, at the request and cost of Grantor, such further instruments, documents and release forms as Grantor may reasonably request or are

required to more effectively release, terminate, discharge, and extinguish any such liens and security interests upon such Released Collateral.

This Release of Trademark Security Interest shall be binding upon the Administrative Agent, its legal representatives, assigns and successors. The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release of Trademark Security Interest.
