RESTATED CERTIFICATE OF INCORPORATION OF

FIRST: That at a meeting of the Board of Directors of the Corporation resolutions were duly adopted setting forth a proposed amendment to the Restated Certificate of Incorporation of the Corporation and declaring said amendment to be advisable. The proposed amendment is as follows:

Article FIRST of the Restated Certificate of Incorporation of the Corporation shall be amended by replacing the Article thereof numbered FIRST so that, as amended, said Article shall be and read as follows:
