**RELEASE**

Reference is made to the Security Agreement dated as of June 7, 2005 (as may be amended, amended and restated, modified or supplemented from time to time, the "**Original Security Agreement**") by Luvata Buffalo, Inc. (formerly Outokumpu American Brass, Inc.), Luvata Franklin, Inc. (formerly Outokumpo Copper Franklin, Inc.) and Luvata Ohio, Inc. (formerly Outokumpu Copper Nippert, Inc., and together with Luvata Buffalo, Inc. and Luvata Franklin, Inc., collectively the "**Continuing Assignors**") and Luvata Grenada LLC (formerly Outokumpu Heatcraft USA LLC; the "**Released Assignor**") to Nordea Bank Finland Plc, as security agent (the "**Security Agent**").

Upon the satisfaction or waiver of the conditions precedent contained in that certain global release letter dated as of 23 August 2007 from Nordea Bank Finland Plc to Luvata International Oy (as the obligor's agent for, among others, the Released Assignor):

- (i) all of the security interests, liens and pledges granted by the Released Assignor in favor of the Security Agent for the benefit of the Secured Parties (as defined in the Original Security Agreement) under the Original Security Agreement or otherwise are hereby automatically terminated and released with no further action on the part of the Security Agent;
- (ii) the Security Agent shall promptly procure, deliver or execute and deliver all further instruments and documents, and take any other actions, which are reasonably required to evidence the consummation of the termination of the security interests contemplated hereby, in each case at the request and expense of the Released Assignor;
- (iii) the Security Agent hereby authorizes the Released Assignor or its counsel to file on behalf of the Security Agent (at the Released Assignor's cost and expense) any releases, including any UCC termination statements, necessary to effectuate the release contemplated hereunder; and
- (iv) the Original Security Agreement as it relates to the Continuing Assignors remains in full force and effect.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Release by telecopier or electronic mail shall be effective as delivery of an original executed counterpart of this Release.




