**SECOND LIEN TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Second Lien Termination and Release of Security Interest in Trademarks ("Trademark Release") is made as of December 7, 2016, by UBS AG, STAMFORD BRANCH, a branch of a Switzerland corporation (the "Collateral Agent") in favor of CAMP SYSTEMS INTERNATIONAL INC., a Delaware corporation with offices at 999 Marconi Avenue, Ronkonkoma, New York 11779 (the "Grantor").

WITNESSETH:

WHEREAS, Grantor entered into a certain second lien trademark security agreement dated August 18, 2016 (the "Second Lien Trademark Security Agreement") with the Collateral Agent, notice of which was recorded on August 19, 2016 at the United States Patent and Trademark Office at Reel 5859, Frame 0846.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Second Lien Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Second Lien Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Collateral Agent, in and to the Trademark Collateral, including the trademarks listed in Schedule A.


WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in the Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges the Security Interest in and to the Trademark Collateral, and terminates the Second Lien Trademark Security Agreement.


