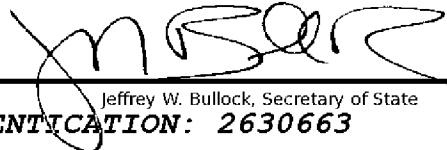

MyPizza Technologies, Inc., a corporation duly organized and existing under and by virtue of the General Corporation Law of the State of Delaware ("MyPizza"), does hereby certify:

FIRST: That the name and state of incorporation of each of the constituent corporations of the merger is as follows:

SECOND: That the Agreement and Plan of Merger and Reorganization (the "Merger Agreement") dated as of August 10, 2015, by and among Biz Farm Inc., a New York corporation ("Biz Farm") and MyPizza, setting forth the terms and conditions for the merger of Biz Farm with and into MyPizza (the "Merger"), has been approved, adopted, certified, executed and acknowledged by Biz Farm in accordance with the requirements of Sections 903(a) and 907 of the Business Corporation Law of the State of New York and MyPizza in accordance with the requirements of Section 252 of the General Corporation Law of the State of Delaware.

THIRD: That the name of the surviving Delaware corporation (the "Surviving Corporation") of the Merger shall be MyPizza Technologies, Inc.

FOURTH: That pursuant to the Merger Agreement, the Certificate of Incorporation of MyPizza as in effect immediately prior to the Merger shall be the Certificate of Incorporation of the Surviving Corporation until thereafter amended in accordance with its terms and the General Corporation Law of the State of Delaware.

FIFTH: That the executed Merger Agreement is on file at the principal place of business of the Surviving Corporation located at 1201 Broadway, Suite 904A, New York, NY 10001.

SIXTH: That a copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation.

SEVENTH: That the authorized stock and par value of the non-Delaware corporation is 200 shares of stock, no par value per share.

EIGHTH: That the merger shall become effective as of the close of business on August 10, 2015.
