1. The Corporation was originally incorporated in Connecticut as Gerber Garment Technology, Inc. on October 31, 1968.
2. Gerber Garment Technology, Inc. was renamed Gerber Technology, Inc. on March 20, 1998.
3. Gerber Technology, Inc. was renamed Gerber Scientific International, Inc. on April 30, 2003.
4. Gerber Scientific International, Inc. was renamed Gerber Technology, Inc. on October 15, 2015.
5. The name of the Corporation immediately prior to the filing of this Certificate of Conversion is Gerber Technology, Inc.
6. The jurisdiction of the Corporation immediately prior to the filing of this Certificate of Conversion is Connecticut.
7. The Corporation will be converted into a limited liability company upon the effective date of this Certificate of Conversion.
8. The name of the limited liability company upon the effective date of this Certificate of Conversion is Gerber Technology LLC.
9. The jurisdiction of the Limited Liability Company upon the effective date of this Certificate of Conversion is Connecticut.
10. This Certificate of Conversion shall become effective at the time of filing.
11. The Plan of Conversion was approved in accordance with Part IV of Chapter 616 of the Connecticut General Statutes.
12. The Articles of Organization of Gerber Technology LLC is attached hereto as Exhibit A.




