**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "*Release*") is made effective as of December 9th, 2016 (the "*Effective Date*"), by and from Linda W. Hart and Milledge A. Hart, III (together, the "*Secured Party*"), to Rmax Operating, LLC, as successor-in-interest to Rmax, Inc.

WHEREAS, the Secured Party and Rmax, Inc., are parties to that certain Security Agreement dated March 8, 1993 (as amended from time to time, the "*Security Agreement*"), pursuant to which Rmax, Inc. granted the Secured Party a security interest in the trademarks set forth in Appendix 1 (the "*Trademarks*");

WHEREAS, such security interest has been recorded in the United States Patent and Trademark Office at Reel 0956, Frame 0228;

WHEREAS, on July 27, 2006, Rmax, Inc. merged with and into Rmax Operating, LLC; and


WHEREAS, all amounts owing and due under the Loan Agreement (as defined in the Security Agreement) have been paid in full, and the Secured Party wishes to evidence the release of its interest in the Trademarks, and retransfer and reassign to Rmax Operating, LLC, without recourse, all of its right, title and interest in and to the Trademarks.


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Release of Security Interest. The Secured Party hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set off against, the Trademarks, including any goodwill of the business symbolized by the foregoing, and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Rmax Operating, LLC.
2. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a signed counterpart of this Release.
