ASSIGNMENT OF TRADEMARK RIGHTS

This **ASSIGNMENT OF TRADEMARK RIGHTS** is made by **INTEGRATED SECURITY SYSTEMS INC.**, a Florida corporation ("*Assignor*"), which has a principal business address of 1876 N.W. 7th Street, Miami, Florida 33125, in favor of **JEFFREY S. WHEREAS, Assignor is currently using and has previously used, and is the sole legal and beneficial owner of, the following United States Trademark Registration:

Registration Number 4,930,155 for the mark known as **ISS LOGO DESIGN** (the "*Mark*") registered on April 5, 2016 with the United States Patent and Trademark Office ("*USPTO*").

WHEREAS, in order to clarify and resolve any questions or issues regarding ownership of the Mark, Assignor desires to convey, transfer and assign to Assignee, and Assignee desires to acquire and accept, all of Assignor's right, title and interest in and to the Mark, including without limitation, registration of the Mark.

NOW THEREFORE, for TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers and assigns unto Assignee, and Assignee hereby acquires and accepts, all of Assignor's right, title and interest in and to the Mark and in, to and under the registration with the USPTO referred to above, together with the goodwill of the business connected with the use of, and symbolized by, the Mark.

The foregoing conveyance, transfer and assignment includes, without limitation, (i) the trademark registrations and trademark applications with respect to the Mark (and the registration with the USPTO referred to above) and all issuances, extensions and renewals thereof; (ii) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; (iii) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and (iv) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

Assignor hereby authorizes the Commissioner for Trademarks in the USPTO and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this trademark assignment upon request by Assignee. Following the date hereof, upon Assignee's reasonable request and at Assignor's sole cost and expense, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, certificates, exhibits, assignments, powers of attorney or other documents, as

may be necessary to effect, evidence, or perfect the assignment of the Mark pursuant to this ASSIGNMENT OF TRADEMARK RIGHTS to Assignee, or any assignee thereof or successor thereto.

Upon execution of this ASSIGNMENT OF TRADEMARK RIGHTS all right, title and interest in and to the Mark (and in, to and under the registration with the USPTO referred to above) shall be owned solely, completely and exclusively by Assignee, free and clear from any and all liens, claims, encumbrances or rights of reversion of any nature.

This ASSIGNMENT OF TRADEMARK RIGHTS shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns. This ASSIGNMENT OF TRADEMARK RIGHTS and any claim, controversy, dispute or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this ASSIGNMENT OF TRADEMARK RIGHTS and the assignment contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Florida, without giving effect to any choice or conflict of law provision or rule (whether of the State of Florida or any other jurisdiction).
