RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of June 29, 2012 (as the same may be amended, modified, extended or restated from time to time, the "Security Agreement") by and among NEBRASKA BOOK COMPANY, INC., a Delaware corporation, formerly known as New Nebraska Book Company, Inc. ("Parent"), CAMPUS AUTHENTIC LLC, a Delaware limited liability company ("Campus Authentic"), COLLEGE BOOKSTORES OF AMERICA, INC., an Illinois corporation ("College Bookstores"), NBC TEXTBOOKS LLC, a Delaware limited liability company ("NBC Textbooks"), NET TEXTSTORE LLC, a Delaware limited liability company ("Net Textstore"), SPECIALTY BOOKS, INC., a Delaware corporation ("Specialty Books"; together with Parent, Campus Authentic, College Bookstores, NBC Textbooks, and Net Textstore, collectively, the "Grantors" and each, a "Grantor"), NEEBO, INC., a Delaware corporation ("Neebo"), NEEBO HOLDING COMPANY, a Delaware corporation ("Neebo Holding"; together with Neebo, the "Guarantors"), WILMINGTON TRUST, NATIONAL ASSOCIATION, a national banking association, in its capacity as ("Collateral Agent"), Grantors granted to Collateral Agent, for the benefit of the Secured Parties (as defined in the Security Agreement), continuing security interests (collectively, the "Security Interests") in and to certain intellectual property held by Grantors, including, without limitation, the trademarks listed on Schedule A (collectively, the "Trademarks"), pursuant to a Notice of Grant of Security Interest in U.S. Trademarks dated June 29, 2012, as filed with the United States Trademark and Patent Office at Trademark Reel 4811, Frame 0918 on June 29, 2012, and a Notice of Grant of Security Interest in U.S. Trademarks dated June 29, 2013, as filed with the United States Trademark and Patent Office at Trademark Reel 5065, Frame 0412 on July 8, 2013, and a Notice of Grant of Security Interest in U.S. Trademarks dated October 1, 2014, as filed with the United States Trademark and Patent Office at Trademark Reel 5376, Frame 0437 on October 7, 2014, and all of the goodwill of the business connected with the use of, and symbolized by, the Trademarks;

WHEREAS, the Security Interests are to be terminated and released in all such Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Collateral Agent, for itself and on behalf of the Secured Parties, hereby releases the Security Interests and waives and relinquishes all rights, powers, privileges and remedies of Administrative Agent with respect to the Security Interests.
