ASSIGNMENT OF TRADEMARKS

WHEREAS, Assignor desires to transfer the entire ownership of the Trademark Rights to Assignee;

WHEREAS, as owner of the Trademark Rights Assignee will have all powers of an owner of the Trademark Rights to use the Trademark Rights in its business, including the ability to market its services with reference to fields installed prior to the date of this Agreement bearing the UBU brand;

WHEREAS, it is desired that the assignment of said registrations and applications be made of record in the United States Patent and Trademark Office and other appropriate Patent and Trademark Offices.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby, grant, assign, transfer, convey and set over unto Assignee, all of Assignor's right, title and interest in and to the Trademark Rights, and all applications and all registrations therefor, and all usages of the trademarks and service marks

that have not been applied for, if any, together with the goodwill of the business symbolized by the Trademark Rights, and all priority rights under any applicable convention, all rights to damages and profits, due or accrued, arising out of past or future infringements of said Trademark Rights, and the right to sue for and recover the same (collectively, the "Trademark Property") the same to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held or enjoyed by the Assignor if this assignment and sale had not been made.

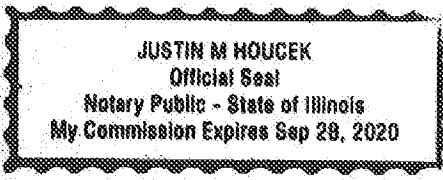
