Pursuant to Title 12, Subtitle 2, Chapter 490.1106 of the Iowa Business Corporation Act, Dermatologic Lab and Supply, Inc. executed the following Articles of Merger:

FIRST: The name of the surviving company is Delasco, LLC, a Delaware limited liability company (the "Surviving Company"), and the name of the corporation being merged into the Surviving Corporation is Dermatologic Lab and Supply, Inc., an Iowa corporation (the "Acquired Corporation"), and merger is to become effective at 11:59 p.m. CDT on October 3, 2016.


FOURTH: The Certificate of Formation of the Surviving Company shall be its Certificate of Formation.
