The Assignee wishes to acquire the rights in and to the Registered Trademark owned by Assignor, and the Assignee agrees to pay the Assignor a total purchase price of One and 00/100 (\$1.00) Dollar in order to acquire said rights.

- 2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Registered Trademark, including without limitation, damages and payments for past or future infringements and/or misappropriations of the Registered Trademark, and
- 3) all rights to sue for past, present and future infringement or misappropriations of the Registered Trademark.

The Assignor further agrees that it will take all reasonable actions that may be required or necessary for securing, completing, or vesting in the Assignee all rights, title, and interest in and to the Registered Trademark and its related property.




