WHEREAS, in or about May 2008, Fluke Electronics Corporation ("FEC") was a corporation organized under the laws of the state of Delaware, having its principal place of business at 9028 Evergreen Way, Everett, Washington 98204;

WHEREAS, in or about May 2008, Fluke Corporation ("Fluke") was a corporation organized under the laws of the state of Washington, having its principal place of business at 6920 Seaway Boulevard, Everett, Washington 98203;

WHEREAS, on or about May 23, 2008, Ircon was the owner of the trademark/service mark registrations for the marks that are the subject of this assignment, as shown in the attached Schedule A and Schedule B (collectively, the "Marks"), which are incorporated hereby by reference;

WHEREAS on or about May 23, 2008, Ircon assigned all right, title and interest in and to the Marks to FEC, along with the goodwill associated therewith, and following thereto, on or about May 23, 2008, FEC assigned all right, title and interest in and to the Marks to Fluke, along with the goodwill associated therewith;

WHEREAS on or about May 23, 2008, Fluke was then the owner in fact of the Marks and the appurtenant goodwill and the parties desire to reflect these facts on the record of the trademark registries where these Marks are registered or pending;

WHEREAS on or about June 30, 2008, an assignment agreement was recorded with the United States Patent and Trademark Office inadvertently setting forth the assignment of certain of the Marks from Ircon to a corporation organized under the laws of the state of Washington by the name of Fluke Electronics Corporation; and

WHEREAS on or about December 20 2010, Ircon merged with FEC;

In consideration of the foregoing and for good and valuable consideration, receipt of which is

hereby acknowledged, FEC for itself and on behalf of predecessor-in-interest Ircon confirms nunc pro tunc the assignment (a) by Ircon to FEC, of all its right, title and interest in and to the Marks together with the appurtenant goodwill symbolized by the Marks, with an effective date of May 23, 2008, and (b) by FEC to Fluke of all its right, title and interest in and to the Marks together with the appurtenant goodwill symbolized by the Marks, with an effective date of May 23, 2008.
