## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Trademark Assignment") is entered into as of October 14, 2016 (the "Effective Date"), by and between Restore Surgical, LLC, a Texas limited liability company having a principal place of business at 15200 Middlebrook Drive, Suite G, Houston, Texas 77058 ("Restore"), and Howmedica Osteonics Corp., a New Jersey corporation having a principal place of business at 325 Corporate Drive, Mahwah, New Jersey 07430 ("Assignee").

WHEREAS, Restore holds the entire right, title, and interest in and to the trademarks and trademark applications listed on the attached Trademark Schedule as well as other trademarks used in connection with the business of Restore and protectable under common law (collectively, the "Marks"), and Restore and an affiliate of Assignee have entered into a separate agreement pursuant to which Restore agreed to transfer all of Restore's right, title and interest in the Marks as directed by the affiliate of Assignee (the "Separate Agreement"), the affiliate of Assignee that is the party to the Separate Agreement having directed that the Marks be assigned to Assignee, and Assignee desires to secure the entire right, title and interest in the Marks, together with all related common law rights and the goodwill of the business connected with the use of and symbolized by the Marks.

NOW, THEREFORE, be it known by all whom it may concern, that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,

1. Restore hereby assigns, transfers and sets over to Assignee, its successors and assigns, and Assignee hereby accepts, all of Restore's entire right, title and interest, whether statutory or at common law, in and to the Marks, together with the goodwill of the business identified through the use of and symbolized by the Marks, in the United States of America and throughout the world, including the entire right, title and interest in and to all claims for damages by reason of past infringement of the Marks, together with the right to sue for, collect, and retain the proceeds relating to any such infringement, and in and to all legal equivalents of the Marks in foreign countries to the extent any such rights exist in foreign countries.
2. Restore hereby agrees, without further consideration and without expense to Assignee, to sign all lawful papers and to perform all other lawful acts which Assignee may reasonably request to make this assignment of the Marks fully effective.
3. Except as provided for in Section 2 hereof, nothing in this Trademark Assignment shall alter any liability or obligation of Restore or Assignee arising under the Separate Agreement, which shall govern the representations, warranties and obligations of the parties with respect to the Marks. In the event of any conflict or ambiguity between the terms hereof and the terms of the Separate Agreement, the terms of the Separate Agreement shall govern and be controlling.
4. This Trademark Assignment shall be governed by, and construed in accordance with the laws of the State of New York.
5. This Trademark Assignment may be executed and delivered (including electronically) in one or more counterparts, and by the parties in separate counterparts, each of which when executed shall be deemed to be an original, but when taken together shall constitute one and the same agreement.

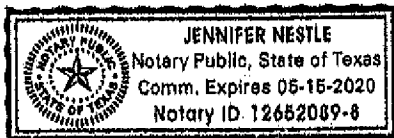
