**ARTICLES OF ORGANIZATION

INCLUDING ARTICLES OF CONVERSION  
[Conversion of H. V. Industries, Inc.]**

Pursuant to North Carolina General Statutes Sections 57D-2-21, 57D-9-20 and 57D-9-22, the undersigned does hereby submit these Articles of Organization Including Articles of Conversion (the "Articles") for the purpose of forming a limited liability company under the laws of the State of North Carolina pursuant to a conversion of another business entity.


