**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of December 14, 2016 (this "Release"), is made by Bank of Montreal, as administrative agent (in such capacity, the "Agent"), in favor of Ariens Specialty Brands LLC, a Wisconsin limited liability company ("Ariens"), as follows:

**WITNESSETH**

WHEREAS, Ariens, the Agent and the other parties thereto entered into that certain Credit Agreement on September 30, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, Ariens granted the Agent a security interest in certain collateral pledged by Ariens pursuant to the Trademark Collateral Agreement, dated September 12, 2011, which was recorded with the U.S. Patent and Trademark Office on September 13, 2011 at Reel/Frame No. 4622/0080 as further described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral"); and

WHEREAS, Ariens has requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at Defender's sole cost and expense, hereby terminates, cancels and releases any security interest of the Agent in the Trademark Collateral and any all rights, title and interests of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.


