## TRADEMARK ASSIGNMENT AGREEMENT

### RECITALS:

- A. Enviroshake Inc. (the “**Assignor**”), is the sole owner and holder of all right, title and interest in and to the trademarks listed in Exhibit A (the “**Trademarks**”), the registrations thereof, and the goodwill represented by the Trademarks.
- B. Allmet Roof Products, Ltd. (the “**Assignee**”) is desirous of acquiring the entire right, title and interest in the Trademarks.
- C. The Assignor and the Assignee are parties to an asset purchase agreement made as of December 3, 2015 (the “**Purchase Agreement**”), pursuant to which, among other things, the Assignor has agreed to sell, transfer, assign, and deliver to the Assignee the Trademarks, and the Assignee has agreed to purchase and accept the Trademarks, subject to the terms and conditions of the Purchase Agreement.
- D. The Assignee is the successor to the business of the Assignor to which the Trademarks pertains and such business will be ongoing and existing.

NOW, THEREFORE, for the consideration set forth in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby sells, assigns, transfers, and sets over unto the Assignee: (a) its entire right, title, and interest in all countries throughout the world in and to the Trademarks, the registrations and applications thereof, together with the entire goodwill attached to the Trademarks; (b) its right to sue and recover for, and the right to profits or damages due or accrued in connection with, any and all past or present infringement or dilution of the Trademarks, and any and all causes of action related thereto; and (c) its entire right, title, and interest in all convention and treaty rights of all kinds, including without limitation all rights of priority in any country of the world, in and to the Trademarks.

The Assignor hereby authorizes the Assignee to record this Trademark Assignment with all appropriate governmental offices. The Assignor agrees to take such further action, execute such additional documents, and, in general, do all lawful things reasonably requested of it by the Assignee to perfect the Assignee’s title in and to the Trademarks and to carry out and fulfill the purposes and intent of this Trademark Assignment.
