FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Payoff Letter, Administrative Agent hereby releases any and all liens and security interests granted by Company in favor of Administrative Agent pursuant to the Trademark Security Agreement, including with respect to the Trademark Collateral (and the trademarks and service marks listed on Schedule A attached hereto).
