TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination") is made as of November 30, 2016 with reference to that certain Intellectual Property Security Agreement (the "Security Agreement"), dated as of February 14, 2014, by and between Machinima, Inc. ("Grantor") and Redpoint Ventures III, L.P., as collateral agent for itself and the other secured parties party thereto, as agent (in such capacity, "Agent"), and amendment thereto, dated February 19, 2015, which are attached hereto as Exhibit A.

WHEREAS, pursuant to that certain Note Purchase Agreement, dated as of February 14, 2014 (as amended or otherwise modified to the date hereof, the "NPA"), by and among Grantor, and the note purchasers party thereto (the "Purchasers") (as amended, restated, supplemented or otherwise modified from time to time, the "2014 NPA"; capitalized terms used herein are used as defined in the NPA), the Grantor and Agent executed the Security Agreement, in favor of the Agent, pursuant to which the Grantor granted to the Agent, for the ratable benefit of Lenders, a security interest in Grantor's right, title and interest in, to and under certain intellectual property owned by Grantor; and

WHEREAS, the Agent has agreed to release all liens on the intellectual property owned by Grantor (the "Released Collateral") granted pursuant to the Security Agreement, and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.



Intellectual Property Security Agreements

INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of February 14, 2014 by and between **MACHINIMA, INC.**, a Delaware corporation ("**Grantor**") to and for the benefit of Redpoint Ventures III, L.P., a Delaware limited partnership, (the "**Collateral Agent**") as collateral agent for itself and the other secured parties listed on the signature pages hereof (each, a "**Secured Party**" and, collectively, the "**Secured Parties**").

RECITALS

A. Each Secured Party and Grantor made certain advances of money and extended certain financial accommodations to Grantor (the "**2013 Loans**") pursuant to that certain Note and Warrant Purchase Agreement dated May 28, 2013 (as amended, the "**2013 Purchase Agreement**") pursuant to which Grantor issued convertible promissory notes (each, a "**2013 Note**," and, collectively, the "**2013 Notes**") to the Secured Parties (such holders of the 2013 Notes, the "**2013 Lenders**").

B. Certain of the Secured Parties (the "**2014 Lenders**") now have agreed to make certain additional advances of money and to extend certain financial accommodations to Grantor as evidenced by those certain Secured Convertible Promissory Notes dated February 14, 2014 executed by Grantor in favor of each such Secured Party (each, a "**2014 Note**" and, collectively, the "**2014 Notes**" and, together with the 2013 Notes, each, a "**Note**" and, collectively, the "**Notes**") and that certain Note Purchase Agreement dated February 14, 2014 by and between Grantor and such Secured Parties (the "**2014 Purchase Agreement**" and together with the 2013 Purchase Agreement, the "**Purchase Agreements**"), such advances, future advances, and financial accommodations being referred to herein as the "**2014 Loans**" and together with the 2013 Loans, the "**Loans**". The Notes and Purchase Agreements are referred to herein collectively as the "**Loan Documents**".

C. The Secured Parties have conditioned the Company's consummation of the 2014 Loans on Grantor granting to Collateral Agent a security interest in certain Copyrights, Trademarks and Patents to secure the obligations of Grantor under the Loans.

D. Pursuant to the terms of that certain Security Agreement, dated of even date herewith, made by Grantor for the benefit of the Collateral Agent (as the same may be amended, modified or supplemented from time to time, the "**Security Agreement**"), Grantor has granted to the Secured Parties a security interest in all of Grantor's right, title and interest in, to or under all of the Grantor's assets. All capitalized terms used but not otherwise defined herein shall have the respective meanings assigned to them in the Security Agreement.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, Grantor hereby represents, warrants, covenants and agrees as follows:

To secure the Secured Obligations, Grantor grants and pledges to the Collateral Agent, on behalf of the Secured Parties, a security interest in all of Grantor's right, title and interest in, to and

under its Intellectual Property (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.

Notwithstanding the foregoing, the grant, assignment and transfer of a security interest as provided herein shall not include "intent-to-use" trademarks at all times prior to the first use thereof, whether by the actual use thereof in commerce, the recording of a statement of use with the United States Patent and Trademark Office or otherwise.

This security interest is granted in conjunction with the security interest granted to Collateral Agent, on behalf of the Secured Parties, under the Security Agreement. The rights and remedies of Collateral Agent and the Secured Parties with respect to the security interest granted hereby are subject to the terms of the Security Agreement and are in addition to those set forth in the Security Agreement and the other Loan Documents, and those which are now or hereafter available to Collateral Agent and the Secured Parties as a matter of law or equity. Each right, power and remedy of Collateral Agent and the Secured Parties provided for herein or in the Security Agreement or any of the Loan Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Collateral Agent and the Secured Parties of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Security Agreement or any of the other Loan Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Collateral Agent or the Secured Parties, of any or all other rights, powers or remedies.

Grantor represents and warrants that Exhibits A, B, and C attached hereto set forth any and all intellectual property rights in connection to which Grantor has registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office, as applicable.

In all respects, including all matters of construction, validity and performance, this Security Agreement shall be governed by, and construed and enforced in accordance with, the laws of the State of Delaware applicable to contracts made and performed in such state, without regard to the principles thereof regarding conflict of laws, except to the extent that the UCC provides for the application of the law of a different jurisdiction.

This Intellectual Property Security Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.



AMENDMENT TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "**Amendment**") is entered into as of the 19th day of February, 2015, by and among Machinima, Inc., a Delaware corporation (the "**Company**"), and each of the persons and entities who are signatories hereto (the "**Amending Secured Parties**").

RECITALS

WHEREAS, reference is hereby made to that certain Intellectual Property Security Agreement (the "**IP Security Agreement**"), dated as of February 14, 2014, among the Company, the Secured Parties named therein and the Collateral Agent (as defined therein);

WHEREAS, the Amending Secured Parties constitute (i) the holders holding at least a majority of the outstanding aggregate principal amount of all outstanding secured convertible promissory notes issued by the Company pursuant to that certain Note Purchase Agreement, dated February 14, 2014 and amended on February 19, 2015, and (ii) the holders holding at least sixty-five percent (65%) of the outstanding aggregate principal amount of all outstanding convertible promissory notes issued by the Company pursuant to that certain Note and Warrant Purchase Agreement, dated May 28, 2013 (as amended on July 23, 2013, November 12, 2013, February 14, 2014 and February 19, 2015); and

WHEREAS, the Company and the Amending Secured Parties desire to amend the IP Security Agreement as set forth in this Amendment.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing recitals and the mutual promises and covenants hereinafter set forth and for other good and valuable consideration, and intending to be legally bound hereby, the parties hereto agree to the following:

1. **Amendment to IP Security Agreement.**

a. The second sentence of the fourth to last paragraph of the IP Security Agreement shall be deleted and replaced in its entirety as follows:

"The rights and remedies of Collateral Agent and the Secured Parties with respect to the security interest granted hereby are subject to the terms of the Security Agreement and the Subordination Agreement (as defined in the Security Agreement) and are in addition to those set forth in the Security Agreement and the other Loan Documents, and those which are now or hereafter available to Collateral Agent and the Secured Parties as a matter of law or equity."

b. Each of Exhibit A (Copyrights) and Exhibit C (Trademarks) of the IP Security Agreement is hereby amended and restated in its entirety in the form of Exhibit A and Exhibit C, respectively, attached hereto.

2. **No Further Amendment.** Except as expressly amended hereby, the IP Security Agreement is in all respects ratified and confirmed and all the terms, conditions and provisions thereof shall remain in full force and effect. This Amendment is limited precisely as written and shall not be deemed to be an amendment to any other term or condition of the IP Security Agreement or any of the documents referred to therein.

3. **Effect of Amendment.** This Amendment shall form a part of the IP Security Agreement for all purposes, and each party thereto and hereto shall be bound hereby. From and after the execution of this Amendment by the parties hereto, any reference to the IP Security Agreement shall be deemed a reference to the IP Security Agreement as amended hereby. This Amendment shall be deemed to be in full force and effect from and after the execution of this Amendment by the parties hereto.

4. **Successors and Assigns.** Except as otherwise provided herein, the terms and conditions of this Amendment shall inure to the benefit of and be binding upon the respective successors and assigns of the parties.
