RELEASE OF SECURITY INTERESTS IN CERTAIN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS
dated April 26, 2001 by Harris Trust and Savings Bank, as agent as hereinafter described;

WITNESSETH:

WHEREAS, Harris Trust and Savings Bank, individually and as agent (the "*Agent*") for itself and certain other lenders (collectively, the "*Banks*"), and Ragus Holdings, Inc., a Delaware corporation (the "*Company*"), are parties to a certain Trademark Collateral Agreement dated July 28, 2000 (the "*Agreement*"), which was recorded with the United States Patent and Trademark Office on August 7, 2000 at Reel 2129 Frame 0693, pursuant to which the Company assigned, mortgaged, pledged, and granted a security interest in forty trademark registrations and applications and the underlying trademarks and trademark licenses and certain other property as security for the "*Obligations*" (as defined in the Agreement) owed to the Banks and the Agent;

WHEREAS, the Company has requested that the Agent release its security interest in seventeen of these trademark registrations and the underlying trademarks and trademark licenses and certain other property as listed on Schedule A attached hereto (collectively the "*Trademarks*");

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Agent releases its security interests in and assignment, mortgage and pledge of, and reassigns, grants and conveys to the Company, without any representation, warranty, recourse or undertaking by the Agent, all of its right, title and interest, if any, in and to:

(i) Each trademark and trademark registration listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark and trademark registration; and

(ii) Each trademark license listed on Schedule A hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and

(iii) All proceeds of the foregoing, including without limitation any claim by Company against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A hereto or of any trademark licensed under a trademark license listed on Schedule A or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collected said damages.



Except with respect to the Trademarks, the Agreement shall remain in full force and effect in accordance with its original terms.

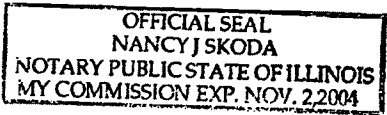
